Conflict of Interest Code

1.04.091

Purpose

Pursuant to the provisions of Government Code sections 87303, 87306 and 87306.5, et.seq. the District hereby adopts the following Conflict of Interest Code. Nothing contained herein is intended to modify or abridge the provisions of the Political Reform Act of 1974 (Government Code Section 81000). The provisions of this code are additional to Government Code Section 87100 and other laws pertaining to conflicts of interest. The definitions contained in the Political Reform Act of 1974, regulations of the Fair Political Practices Commission (2 Cal Adm. Code Sections 18100, et seq.) and any amendments to the Act or regulations, are incorporated by reference into this Conflict of Interest Code.

1.04.092 Designated Positions

The positions listed in Section 1.04.097 are designated positions. Officers and employees holding those positions are individuals deemed to make, or participate in the making of decisions that may foreseeably have material effect on a financial interest. Individuals who hold a designated position shall be referred to as "designated member" in this Manual.

1.04.093 Disclosure Statements

Designated members, if any, specified in Government Code Section 87200 shall file statements of economic interest pursuant to Article 2 of Chapter 7 of the Political Reform Act, Government Code Sections 87200 et seq. With respect to all other designated members, they shall disclose all those types of economic interests set forth in the latest adopted standard form for statements of economic interests as adopted by the Fair Political Practices Commission. It has been determined that the financial interests set forth in a designated member's disclosure categories are the kinds of financial interests which he or she foreseeably can affect materially through the conduct of his or her office.

1.04.094 Place and Time of Filing

- a) The Clerk of the Board of Supervisors shall be the official filing officer. However, all designated members required to submit a statement of financial interests shall statements of economic interest with the Tuolumne County Clerk's Office.
- b) A designated member required to submit a statement of financial interest shall submit an initial statement within 30 days after the effective date of this Code.
- c) Merit system employees appointed, promoted or transferred to designated positions shall file initial statements within 30 days after date of employment.
- d) All other employees appointed, promoted or transferred to designated positions shall file initial statements not less than 10 days before assuming office (or, if subject to confirmation, 10 days before being confirmed), unless an earlier assumption of office is required by emergency circumstances, in which case the statement shall be filed within 30 days thereafter.

- e) All designated members shall file annual statements no later than April 1st. This initial statement need not disclose income. Annual statements shall include holdings as of that date and income received and dates of acquisition and disposal of investments and real property that occurred since the filing of the previous statement.
- f) A designated member required to file a statement of financial interest with any other agency, which is within the same territorial jurisdiction, may comply with the provisions of this Code by filing a duplicate copy of the statement filed with the other agency, in lieu of an entirely separate document.

1.04.095 Contents of Disclosure Statements

Disclosure statements shall be made on forms supplied by the Clerk of Tuolumne County as prescribed by the Fair Political Practices Commission, and shall contain the following information:

a) Contents of Investment and Real Property Reports:

When an investment, or an interest in real property, is required to be reported, the statement shall contain:

- 1) A statement of the nature of the investment or interest;
- 2) The name of the business entity in which each investment is held, and a general description of business activity in which the business entity is engaged.
- 3) The address or other precise location of the real property;
- 4) A statement whether the fair market value of the investment or interest in real property, exceeds Two Thousand Dollars (\$2,000.00), exceeds Ten Thousand Dollars (\$10,000.00), or exceeds one hundred thousand dollars (\$100,000.00), or exceeds One Million Dollars (\$1,000,000.00). This information need not be provided with respect to an interest in real property that is used principally as the residence of the filer.

b) Contents of Personal Income Reports:

When personal income is required to be reported, the statement shall contain:

- 1) The name and address of each source of income aggregating Five Hundred Dollars (\$500.00) or more in value, or Fifty Dollars (\$50.00) or more in value if the income was a gift, and a general description of the business activity, if any, of each source;
- 2) A statement whether the aggregate value of income from each source was greater than One Thousand Dollars (\$1,000.00) or less, greater than One Thousand Dollars (\$1,000.00), or greater than Ten Thousand Dollars (\$10,000.00), or greater than One Hundred Thousand Dollars (\$100,000.00);
- 3) A description of the consideration, if any, for which the income was received;

4) In the case of a gift, the name, address, and business activity of the donor and any intermediary through which the gift was made; a description of the gift; the amount or value of the gift; and the date on which the gift was received.

c) Contents of Business Entity Income Reports:

When income of a business entity, including income of a sole proprietorship, is required to be reported, the statement shall contain:

- 1) The name, address, and general description of the business activity of the business entity;
- 2) The name of every person from whom the business entity received payments if the filer's pro rate share of gross receipts from such person was equal to or greater than Ten Thousand Dollars (\$10,000.00);

d) Contents of Management Positions Reports:

When management positions are required to be reported, designated employees shall list the name of each business entity not specified above in which they are a director, officer, partner, trustee, employee, or in which they hold any position of management, a description of the business activity in which the business entity is engaged, and the designated member's position with the business entity.

e) Initial Statement:

The initial statement filed by a member appointed to a designated position shall disclose any reportable investments and interests in real property.

f) Acquisition or Disposal During Reporting Period:

In the case of an annual leaving office, if the investment, or interest in real property, was partially or wholly acquired or disposed of during the period covered by the statement, the date of acquisition or disposal.

1.04.096 Disqualification

Designated members must disqualify themselves from making, participating in the making, or using their official positions to influence the making of any governmental decision which foreseeably have a material financial effect, distinguishable from its effect on the public generally on:

- a) Any business entity in which the designated member has a direct or indirect interest worth more than Two Thousand Dollars (\$2,000.00).
- b) Any real property in which the designated member has a direct or indirect interest worth more than Two Thousand Dollars (\$2,000.00);
- c) Any source of income, other than loans by a commercial lending institution in the regular course of business on terms available to the public without regard to official status, aggregating Five

Hundred dollars (\$500.00) or more in value received by or promised to the designated member within twelve months (12) prior to the time the decision is made; or

d) Any business entity in which the designated member is a director, officer, partner, trustee, employee, or holds any position of management.

The effects of a designated member's financial interests of a decision by a landowner voting district to set ad valorem property tax assessments is not distinguishable from the effects such a decision will have on the public generally within such a district. The effects of a designated member's financial interests of a decision by a utility district to set rates is not distinguishable from the effects such a decision will have on the public generally unless the designated member's financial interest constitutes more than two percent (2%) of the users to whom the rate will be applicable.

No designated member shall be prevented from making or participating in the making of any decisions to the extent his or her participation is legally required for the decision to be made. The fact that the vote of a designated member who is on a voting body is needed to break a tie does not make his or her participating legally required for purposes of this section.

When a designated member determines that he or she should not make a decision because he or she has a financial interest in it, the determination not to act must be accompanied by disclosure of the financial interest. In the case of a voting body, this determination and disclosure shall be made part of the agency's official record; in the case of a designated member who is the head of an agency, this determination and disclosure shall be made in writing to his or her appointing authority; and in the case of other designated members who are also employees, this determination and disclosure shall be made in writing to the designated member's supervisor.

Nothing in this Section shall be construed to inhibit or prohibit a designated member from taking appropriate action when confronted with an emergent situation. Employees shall not defer critical decisions to higher authority on the basis of a possible conflict of interest. As soon as practicable following the action, the employee making such decisions shall notify his immediate supervisor in writing of the facts and circumstances surrounding the making of the decision.

This Code has the force and effect of law. Designated members violating any provision of this Code are subject to the administrative, penal and civil sanctions provided in the Political Reform Act, Government Code Sections 81000-91014.

1.04.097 Designated Positions

a) CATEGORIES

1) Members, Board of Directors 1-2-3

2) Fire Chief 1-2-3

1.04.098 Categories

a) Category 1

Persons in this category shall disclose all interests in real property within the jurisdiction. "Real property" means any interest or option to purchase an interest in any real property, but does not include a home or property used by the owner primarily for personal or recreational purpose. Real property shall be deemed to be within the jurisdiction if the property or any part of it is within the unincorporated area of Tuolumne County or within the corporate boundaries of any city for which the Office of County Counsel provides primary services.

b) Category 2

Persons in this category shall disclose all investments. Investments means:

Any financial interest in or security issued by a business entity, including but not limited to common stock, preferred stock, rights, warrants, options, debt instruments, if the business entity or any parent, subsidiary or otherwise related business entity has an interest in real property in the jurisdiction, or does business or plans to do business in the jurisdiction, or has done business within the jurisdiction at any time during the two years prior to the time any statement or other action is required under this title. No asset shall be deemed an investment unless its fair market value exceeds one thousand dollars (\$1,000). The term "investment" does not include a time or deemed deposit in a financial institution, shares in a credit union, any insurance policy, or any bond or other debt instrument issued by any government or government agency. Investments of any individual includes a pro rata share of investments of any business entity or trust in which the individual or spouse owns, directly or indirectly or beneficially, a ten percent interest or greater.

c) Category 3

Persons in this category shall disclose all income or gifts received from any source located or doing business within Tuolumne County. Income received from a public agency need not be disclosed. For purposes of exemption, the term "income from a public agency" includes County salary and income derived from publically operated schools for teaching or consulting activities.

1.04.099 Board Members as Employees and/or Volunteers

In an effort to prevent any actual or potential conflicts of interests, an individual, while serving as an appointed or elected member of the Board of Directors of the District shall not serve in the capacity of a volunteer firefighter or other position in the District.
